Hello! Happy Thursday!

As you may have heard, there was a bus wreck on Buffalo Road yesterday around 2:00p.m. As you can see by the attached pictures, this was very scary for the students and driver of the bus. From what my SRO at Fairview told me, it was the fault of the small truck (in the attached pictures) being over the line.

I was thinking about this all night because getting the call that there was a bus wreck is never a call you want to get. I know how many buses/students travel that road each and everyday and I know how dangerous the road is! My parents live right at the driveway where the accident took place so I grew up on that road. My husband, Mitch Cupples, and I have been painting my grandmother's house the last few weeks (which shares the same driveway as my parents) and we have been blown away by how much traffic is on that road (and how reckless they drive!!!).

Everytime we pull out of the driveway, we are taking our life in our hands because of the blind curve and the way the cars are flying around it. I've pulled out multiple times and almost been hit by a car that wasn't there when I started pulling out of the driveway, but then came flying around the blind curve going 50+ miles and hour.

If it was just the driveway and my parents I wouldn't be sending this email, but it is about more than just that. It is about every single person that travels that road day in and day out and about the buses/students that are on the road each day.

I don't know how to start the process, but I would like to see how we can get the ball rolling on getting Buffalo Road widened with a line in the middle of the road. I know it's a big job and a lot to ask, but it should have been done a long time ago. There is the huge field area (across from my parents property) and no houses on that side of the road so I know if nothing else, the road could be widened until you get to the bridge on Buffalo Road.

Can you gentlemen please help me? I don't know how the process works, but I know that starting with my county commissioners is the place to start.
