

RE: American Nuclear Site

I met on site at American Nuclear (ANC) on Friday, Sept. 3rd with the following representatives of Tennessee Department of Environment and Conservation (TDEC) for the purpose of discussing path(s)forward for the American Nuclear site: Deputy Commissioner Greg Young, Mark Andrews, DRH Environmental Field Office Manager, Steve Sanders, Director of Remediation, and John LeCroy, Knoxville Regional Director-Office of External Affairs.

We discussed the site, physically walked the site, and visually inspected the building and grounds. The TDEC team reviewed a timeline of the history of the site.

TDEC officials are willing to assist, but there is a lot to sort out in terms of possible paths forward. A lot of discussions will need to take place, and the last I spoke with TDEC officials and reported to Commission, they were awaiting appointment of an EPA Region Administrator.

While there is an earnest desire to get ANC cleaned up once and for all, there are no promises. There is excitement, collaboration and a very positive spirit, but as there are many moving parts, there are no promises. But with that said, I am very optimistic.

I did check in with TDEC officials following December 2021's Commission Meeting. Director of Remediation Steve Sanders responded "I am hopeful that we will hear back from EPA shortly now that they have appointed a new Regional Administrator."

ANDERSON COUNTY FIRE COMMISSION BYLAWS

I. <u>Organizational Name</u>

This committee of Anderson County Government shall be known as the "Anderson County Fire Commission."

II. Mission

It is the declared mission of the Anderson County Fire Commission to improve emergency services to Anderson County residents by working together to coordinate training opportunities, ensure equipment interoperability, establish relationships, to enhance mutual aid with all emergency response agencies in Anderson and surrounding counties, and present to the Anderson County Legislative Body issues concerning future development of emergency response in Anderson County.

III. Membership

A. Agency Membership (Voting Status) shall be comprised of the following:

Andersonville Volunteer Fire Department;

Briceville Volunteer Fire Department;

Claxton Volunteer Fire Department:

Marlow Volunteer Fire Department;

Medford Volunteer Fire Department;

Anderson County Rescue Squad;

Clinton Fire Department;

Rocky Top Fire Department;

Norris Public Safety:

Oak Ridge Fire Department;

Oliver Springs Fire Department; and

Two sitting Anderson County Commission representatives appointed by the Anderson County Legislative Body.

B. Associate Members (Non-Voting Status) shall be:

Anderson County Emergency Management;

Anderson County Emergency Medical Service:

Y-12 Fire Department;

ORNL Fire Department;

Anderson County Sheriff's Office; and

American Red Cross

IV. Voting Rights

- A. Each member agency shall have one vote.
- B. The Chief of each fire department has priority voting status for his/her agency; however, the Chief may appoint a designee to cast the agency's vote on any matter. The Chief shall submit a list of designees in order of priority that can vote in his/her absence for their respective agency. The list may be amended by the Chief at any time, but must be submitted in advance and maintained by the Fire Commission Secretary. In the Chief's absence, the appointed designee shall cast the member agency's vote on any matter brought before the Fire Commission.
- C. Associate Members shall not vote.
- D. The Chair and Vice-Chair shall be allowed to vote on any matter coming before the Fire Commission.
- E. A quorum is considered a majority of the Fire Commission voting membership and all measures shall pass by a majority of the membership present at the meeting. Members shall abstain for cause for matters that involve a direct personal benefit.

V. Membership Terms

- A. Department Chiefs shall serve throughout their term of office.
- B. County Commissioners shall be appointed by the Anderson County Legislative Body to serve a two (2) year term, with the Legislative Body filling any vacancy as may occur.

VI. Officers

A. Officers of the Anderson County Fire Commission shall be:

Chair: County Commissioner

Vice-Chair: Fire Chief

Secretary: Fire Chief or other non-voting member

B. Officers Responsibilities:

- 1) <u>Chair</u>: The Chair shall conduct the meetings, set the agenda and report to the County Commission on meeting outcomes. The agenda shall be comprised of input from Fire Commission Membership and published to Membership three days in advance of the meeting date.
- 2) <u>Vice-Chair</u>: The Vice-Chair shall conduct the meetings in the absence of the Chair. The Vice-Chair shall serve in any other capacity as directed by the Chair.
- 3) <u>Secretary</u>: The Secretary shall prepare for publication to the Membership and County Commission minutes of all meetings. The Secretary shall also prepare other correspondence including meeting agendas and public notices of meeting dates as directed by the Chair.

VII. Election of Officers

- A. Officers shall be elected in September of each year.
- B. In the event a vacancy occurs in one of the commission representative appointments, the County Legislative Body shall elect a qualified Member to serve the remaining term of office.

VIII. Meetings

- A. Meetings shall be held on the first Tuesday of every month at 6:30 PM in the Anderson County Courthouse, or other designated location. The meetings shall be limited in length to ninety (90) minutes. Meeting time length may be extended by majority vote during the meeting. Meeting agenda requests must be submitted to the Chair by noon on the second Wednesday.
- B. All regular meeting shall be publicly noticed in a newspaper of general circulation in the county at least five (5) days prior to the meeting date.
- C. The Fire Commission may vote to call additional special called meetings to discuss and vote on timely issues, with all Members and the public notified at least five (5) days in advance of such called meetings.

IX. Reports/Requests to County Commission

- A. Any issue brought to the Anderson County Legislative Body by an Anderson County Fire Commission Member shall be heard in advance and approved by vote of the Fire Commission Membership if said issue affects more than one Member Department.
- B. Any Fire Commission Member may address County Commission regarding issues affecting only that Member's individual department, provided that the issue does not involve county monetary appropriation or in-kind contribution. All requests for county funding or in-kind contributions shall be brought before the Fire Commission for approval.

X. Robert's Rules of Order

The most recent edition of Robert's Rules of Order shall govern any issue not covered by these Bylaws.

XI. Modification of Bylaws

Any modifications, amendments or changes to these Bylaws must be placed on the meeting agenda in advance and shall be approved by majority vote of the membership at two consecutive regularly scheduled monthly meetings.

- A motion was made by Brent Galloway and seconded by Art Miller to approve the FY 2023 budget as amended.
 Motion passed. Amended budget attached.
 - An amendment motion was made by Brent Galloway and seconded by Beth Hickman to adjust the director's salary from \$59,702 to \$65,000 and increase the budget to reflect said salary and associated benefits, which would not negate the director's eligibility to receive any cost of living raises in addition to the salary adjustment that are approved by County Commission for county employees. Motion passed.
- A motion was made by Michael Foster and seconded by Veronica Greear to increase the Hotel/Motel tax revenues by \$100,000 to be expended on additional marketing efforts. The \$100,000 increase in revenue is already reflected in the actual revenues. This budget amendment would allow the tourism council staff to perform additional marketing in this current budget cycle. Motion passed.
- A motion was made by Tim Isbel and seconded by Brent Galloway to seek permission from Anderson County
 Commission to sell the Anderson County Welcome Center through the bid process, obtain an appraisal to
 determine a minimum price, reserve the proceeds from the sale and work with the Anderson County Chamber of
 Commerce and Anderson County Economic Development Association to purchase property and build a new
 facility. Motion passed. Stephanie Wells and Rick Meredith will present the proposal to County Commission at
 their regularly scheduled meeting in January during the public presentation portion of the agenda then follow up
 with commission at the Operations meeting in February.

Executive's Report, given by Stephanie Wells

• Wells presented the Annual Website Visitation and Social Media Report. The AdventureAnderson.com website had 123,512 visitors that visited 250,345 pages, which is 2.01 pages per session. The annual website visitation is down 3.36% from 2020 but was up 9.89% from 2019, which is due to the creation of a new website and the interest in regional travel during COVID in 2020. The Adventure Anderson Facebook page has 18,155 total

followers and reached 983,112 users in 2021 organically and 210,100 through paid advertisement. Adventure Anderson Instagram page reached 27,140 users. See the attached report for more information.

- The Tourism Council is in the process of meeting with Tourism Partners in Anderson County to obtain feedback for the 2022-2023 Marketing Campaign. The results and associated budget will be presented at the April meeting.
- Wells gave an update on the Three Star Grant Promotion. The videos are produced and the digital campaign will start on January 15th.
- The Tourism Council staff will be attending the Cincinnati Boat Show on January 14th through 23rd and the Indianapolis Boat Show on February 18th through 27th.
- The Tourism Council is assisting County Commission and the City of Rocky Top with the Adventure Tourism District re-application process and the City of Oliver Springs with their initial application.
- Wells attended the City of Norris's public meeting on their proposed Short-Term Rental Ordinance and provided feedback to the Council Board Members. The City of Norris will be working through putting that ordinance in place in the coming months.
- The Tourism Council staff is assisting with the Norris Freeway Scenic Byway website and helping formulate a committee to manage the program of work.
- The bids were submitted for the Anderson County Park Campground expansion at 2 p.m. on January 11, 2022.
- The Tourism Council staff is working with the Norris Lake Project Team to produce the NATS Poker Fun on April 30th.
- Wells is working with the City of Oliver Springs to get legislation passed that would allow off-road vehicles on state Hwy 62 and 330 located within the city limits.








Anderson County ADA Oversight Committee Minutes Jan. 10th

Present: ADA coordinator Roger Lloyd and Louise McKown, chair of the ADA committee

Assistive listening devices:

Roger will ask Brian for a quote from the company that installed the assistive listening devices in all six of our court room to have them for the meeting room in 118A. Louise requested it for two reasons. One is that technically 118A is an assembly space. When Louise and her sister Anne measured the length of the pews and the number of pews based In all our courtrooms on what is considered the measurement of the width of what a typical person would need to sit in a pew without touching someone else, they discovered most courtrooms need more than the allotted four receivers we received that the ADA requires. This is especially true for Circuit Court room. However, in talking with Court Clerk Rex Lynch they are not often requested. But in talking with General David Clark, they are requested more than in Juvenile Court. Having a set of four receivers in Room 118A could be used when meetings are held there, and can be used by the courts if more than four receivers are requested when not all receivers are being used in a meeting in Room 118A or a meeting isn't being held there.

Roger also showed Louise one large white sign that the installer him to alert people that the assistive listening devices are available in a court room. The sign has the symbol of an ear, which is required when assistive listening devices are installed. The Courthouse already has signs, but the words under the ear symbol aren't as bold as the blue print on the sign given to Roger when the new devices were installed. Nor does the old signs say, "ask for receivers inside the room"----or words to that affect. The sign can still be used for 118A or if a sign isn't at the Oak Ridge General Sessions court. If the white signs with bold blue print don't cost much, we may request more of them for all the courts.

Emergency Evacuation Plan:

Louise learned that the emergency evacuation plan written in 2013 was finally passed by County Commission. Jerry Creasey sent her a copy of it. This plan states that people needing assistance to get to the first floor should in all instances should congregate at the central staircase near the elevator. The ADA technically called an "Area of Refuge" and a sign with Braille and raised print should be mounted there on all three floors. The ADA regulations states how high how high the signs should be mounted and should be placed on the latch side of the door. Louise will do a Google search to find out where these signs can be purchased and the cost of them.

However, Roger said that he thought the Area of Refuge was to be at the stairwells near Room 312 and where the Purchasing offices are. He also said that Brian Young was on both floors measuring for an installation of phones near the exits near Room 312 and near the purchasing office....not near the elevator. These phones are to be used by individuals during an emergency evacuation to alert 911 that there are people there needing to be rescued. Not everyone owns a smartphone, sometimes people lose or don't bring them with them, and ol- style flip phones aren't powerful enough to call anyone outside the Courthouse.

Initially when the evacuation plan was written, it asked that the area of refuge be at the elevator. The reasoning was that if we had a tornado or earthquake, windows in the stairwells might be blown out. But those instances have rarely or ever happened in Clinton. Roger will ask Mayor Frank where the actual areas of refuge will be.

Updating the transition plan with details that TDOT wants to see:

In November, Louse requested that Roger give her an updated transition plan to give the county commission a list of what was done in 2021. However, the spreadsheet showed thar we did not do anything in 2021, when in fact we did. In the past TDOT asked for the list every year. Now they want the list in December 2023. Not only does TDOT want the list of items done, but also their cost per item AND the date of completion. However, Louise fears that if we wait to 2023 to document what has been done, we will forget some of it. In other words, we actually have to report that we did follow through with implementing the ADA transition plan and did spend money to do so.

The report Roger gave Louise said only four drinking fountains in the Courthouse were installed, when in fact all six have been installed. It did not quote how much was spent to strip a section of the Senior Center with accessible parking spaces. The report did not document that Roger raised the accessible parking signs nearest to the entrance of the Larry Dickens Building.

Recently, Dr. Parrot gave the county commission a list of what Anderson County Schools did for ADA compliance work done. Some of what was listed was done in 2020. But it did not include cost or date of completion. This is important information that the County needs to document, because many of these schools are polling sites that are on the county's ADA transition plan. Elections are a service that the county provides, so we must document work that is done at polling sites. Roger will call Clay McKamey to get information of cost and date of completion for each item.

The City of Clinton owns the sidewalks and parking lots around the Courthouse that have been done in 2021 and in January 2022. However, the county's transition plan includes parking spaces and curb cuts around the Courthouse. Roger will call the man in charge of doing all the work done in the parking lot and sidewalks around the Courthouse for details involving the new entrance to the Courthouse. The City of Clinton has moved the accessible parking signs to the new parking area near the new entrance from the old entrance facing N. Main Street. They have not yet replaced the curb cuts that were not ADA compliant with a new curb. In some ways this may be a good thing because the old entrances are now emergency exits. In an emergency, people using ability devices can use these curb cuts to escape quicker than going to the new curb cut. But they still are not ADA compliant and we need to discuss if they can be made to be in compliance.

Louise will call Oak Ridge Schools and Clinton Schools to geta report from them on what ADA work they have done in 2021 or plan to do in 2022 asking them to give us cost and the date of completion.

<u>The next ADA meeting</u> will be February 7th at 3pm in room 312. We plan to have Brian Young to give us a demonstration of the new assistive listening devices and tell us where they will be stored. We also hope to see the architectural design for the new witness room, archives and clerk's office.
