Call to Order

Mayor Frank called the meeting to order at approximately 1 p.m.

Approval of Meeting Minutes

Motion by Commissioner Meredith, second by Finance Director Holbrook to approve, as presented, the minutes of the October 5, 2021 meeting. Motion carried by voice vote.

Items for Action and/or Discussion

- Upcoming RFPs On a motion made by Commissioner Meredith and seconded by HR
 Director Whitaker, the Board asked CBIZ to add language to County-Paid Life Insurance
 RFP to include original coverage and an increase in dependent coverage to \$10,000. This
 will allow the Board to review all the options and compare pricing for the upcoming
 fiscal year. Motion carried by voice vote.
- 2. HRA or Coaching, and Tobacco Cessation Program incentives The Board, on a motion by Finance Director Holbrook, seconded by Commissioner Meredith, chose to keep the current incentives in place for the fiscal year beginning 7/1/2022. Motion carried by voice vote.
- 3. Employee Benefit Survey On a motion by Commissioner Meredith and a second by Finance Director Holbrook, the Board approved CBIZ to work with BCBSTN and their actuarial team to determine associated cost as a group and individual if the county were to lower the health plan deductibles and maximum-out-of-pocket expense. Motion carried by voice vote.

Old Business

- 1. Current Retiree Benefit Guidance It was asked that input be gathered from the county law director, and possibly running numbers with CBIZ, before the Board provides guidance.
- 2. New Mom Room Mayor Frank asked that the federal requirements for such a room be provided to Board members. HR Director Whitaker said space is required by the Pregnant Workers Fairness Act of 2020. It was stated that the Finance Department has offered to give up its storage room on the first floor to provide space for a "new mom room" that can be secure and private. A portion of wellness funds approved by the Board will be used to furnish the room.

- 3. Aeromedical Coverage HR Director Whitaker said the HR Advisory Committee had recommended to sending to the Board of Trustees that the county provide the AirMedCare benefit for employees. HR Director Whitaker said, with current calculations, it could cost the county \$29,705 per year to provide this benefit to all full-time employees, and about \$36,000 per year to provide the benefit to all full-time and part-time employees. It was discussed that such an expense would have to bid out under purchasing guidelines. Motion by Finance Director Holbrook, seconded by Commissioner Meredith to ask CBIZ to put this benefit out for bid and look at the costs later. Motion carried by voice vote.
- 4. SaveonSP This program will start 2/1/2022, rather than 1/1/2022.
- 5. Premise Health Transition HR Director Whitaker said the transition from CareHere to Premise Health has had several issues, and the HR team is working with CBIZ to address problems.
