- Commissioner Isbel made a motion for a member of the Legislative Body be a resident of the County for one year prior to election. Seconded by Commissioner Mead. Voting aye: Smallridge, Isbel, White, Mead, Beauchamp and Stonecipher. Voting No: Fritts Absent: Emert. Motion carries.

- Mayor veto to remain 10 days - written in compliance with State Statute.

- Commissioner Isbel made a motion that to recall an elected County Office a petition must be signed by at least fifteen percent (15%) of registered voters. 2/3 of the Legislative Body and after 6 months of service. Seconded by Commissioner Mead.  
Commissioner Smallridge amended to 20%, 2/3 and 6 months.  
Commissioner Fritts amended to one year in office. Motion failed for no second. Commissioner Isbel changed his original motion to go with Commissioner Smallridge. Voting Aye: Smallridge, Isbel, White, Mead, Beauchamp and Stonecipher Voting No: Fritts Absent: Emert. Motion passed.

- 6 year mandatory review of the Charter – within guidelines of State Statute.

Page 35, Section 8.08 Subsection E

- Conflict of Interest Issues – in accordance with State Law.

- Any Lawyer suspended or barred from the practice of law shall immediately be suspended without pay until the attorney’s license is reinstated or revoked according to law.
