Anderson County Government Intern Hiring Policy

Purpose

Anderson County Government periodically employs student and career interns for periods when they are available. The purpose of this policy is to provide individuals with exposure to County government in action through public service. This exposure illustrates how Anderson County's system of government relates across various County departments and offices and into the Anderson County community at large.

Procedures

- Facilitation. The Human Resources and Risk Management Department (HR) will facilitate the offering of paid internship opportunities for individuals who have a minimum of three years high school academic credit. Any student on academic or disciplinary probation will not be permitted to apply for an internship.
- Authorization. Hiring managers who plan to add interns for specific assignments must complete a County intern request form. The following must be included on the requisition form: a) hours of work, b) duration of the expected work, and c) proposed rate of pay for the student worker.

Requisitions for these positions will be routed to HR after department head approval has been obtained.

- Application. All individuals will be required to complete a Anderson County Intern Application prior to the start date of the public service experience. The application is meant to gather individual-specific information with respects to interests, future goals, and availability in order to allow a meaningful match to be provided for both the County and the individual. The application will be kept on file with the County Human Resources and Risk Management Department.
- Compensation. Interns will be paid no less than the minimum hourly rate, not by stipend, for all hours worked. All hours must be tracked to ensure proper and timely payment of wages in accordance with the Fair Labor Standards Act.
- Orientation. An intern will be provided with an abbreviated orientation program that will highlight key aspects of the position the intern will be engaged in as well as all County policies with which he or she will be expected to conform to during the specific term of employment. This orientation will exclude any discussion of programs and policies, including many of the benefits plans, which do not apply to specific-term employees.
- Department Orientation. Each intern will be provided with an in-depth review of department functions and activities and the
 interaction of these activities with the work the intern will be performing. The department review will be conducted by the
 department manager and team leads during the first week of employment.
- Progress Report. Due to the short-term assignment of interns, and in accordance with any school/university reporting requirements for students, the department manager will be responsible for providing a narrative report of the intern's assignments and progress at the close of each month the intern is engaged. A copy of the monthly progress report will be forwarded to the HR department for record-keeping and reporting purposes.
- Final Report and Out-processing. In the week in which an intern's assignment ends, the department manager will provide a final
 progress report in addition to any report required by the educational institution a student attends. The HR department will schedule
 an out-processing interview to be conducted in the week preceding the intern's last day of work.

Leave Donation Policy

Policy Statement

<u>Anderson County</u> recognizes that employees may have a family medical emergency or be affected by a major disaster, resulting in a need for additional time off in excess of their available sick, personal, and vacation time. To address this need, all eligible employees will be allowed to donate accrued paid leave hours from their unused balance to their co-workers in need of additional paid time off, in accordance with the program outlined below. **Participation of this program is strictly voluntary.**

Participant Eligibility

Leave Donors: Employees must be regularly active, full-time employees of <u>Anderson County</u> with a minimum of one year of service to be eligible to donate accrued leave hours.

Leave Recipient: Employees must be a full-time employee of Anderson County to be eligible to request donation of leave. Additionally, recipients must exhaust all other paid leave to receive donated accrued leave.

Guidelines

Employees who would like to make a request to receive donated leave from their co-workers must have a situation that meets the following criteria:

Medical emergency, defined as a medical condition of the employee or an immediate family member that will require the prolonged/extended absence of the employee from duty and will result in a substantial loss of income to the employee due to the exhaustion of all paid leave available. An immediate family member is defined as a spouse, child or parent.

Donation of Accrued Leave

- 1. The donation of accrued leave is strictly voluntary.
- 2. The Director of Human Resources and Risk Management (HR) and/or the Elected Official/Department Head may inform staff of a coworkers need. However, the recipient's identity will not be disclosed to ensure Federal guidelines are met.
- 3. The donation of accrued leave is on an hourly basis, without regard to the dollar value of the donated or used leave.
- 4. The maximum number of hours an eligible employee may donate is 40 hours, or no more than 50 percent of the donor's current balance.
- 5. Employees cannot borrow against future leave to donate.
- 6. Eligible donors must complete the Shared Leave Donation Form and submit to their immediate supervisor or HR.
- 7. Employees who are currently on an approved leave of absence cannot donate accrued leave.

Requesting Donated Leave

Employees who would like to request donated leave are required to complete a Donation of Leave Request Form and submit it to the Anderson County Human Resources and Risk

Management Department (HR) seven (7) days in advance of the need of the leave, when possible.

Requests for donations of accrued leave must be approved by HR, the employee's immediate supervisor and the designated senior leader of the department (Elected Official, Director, etc.). Once leave has been transferred, neither the donor or recipient of the donated leave may revoke the transaction.

If the recipient employee has available leave, this time will be used prior to any donated leave time being allotted. Donated leave will remain available in the recipient employee's sick leave for their use while employed with Anderson County. Receipt of donated leave will not be allowed once an employee is determined to be disabled or does not return to work. Donated leave time cannot be used for severance pay, or paid to an employee in the form of cash or payroll check.

Employees who receive donated accrued leave may receive no more than <u>480 hours (12</u> <u>weeks) within a rolling 12-month period -</u> Hours can be reduced/modified. Once the employee requesting leave returns to full duty or terms employment, the employee is no longer eligible to receive or use donations.

All documentation of this program shall be maintained by HR on a confidential basis in compliance with Federal guidelines. HR will also be responsible for tracking leave and informing payroll of the transfer of donated leave.

Nothing in this policy will be construed to limit or extend the maximum allowable absence under the Family and Medical Leave Act.



The soccer team, after putting in the work all summer, had a great season. They bonded and truly




began to play like the passing team they are. AC went undefeated in districts in the regular and post-season,

Students learned about other cultures through art lessons in conjunction with our social studies classes. We explored aspects of Diwali by crafting and creating in 6, 7, and 8th grade.



ceremony for our veterans. Norwood Middle also received a brand new flag that we were able to display for Veterans Day on our flag pole.




may earn up to three (3) tickets for each monthly drawing by:








Second grade finished up their first Wit and Wisdom module on seasonal changes with a hike to observation point. The best part about teaching in Norris is being in Norris.



Kindergarten students in Ms. Maison's class worked very hard in phonics today. They are pictured differentiating between the letter v and the letter f. Great job kindergarten!






Our Kindergarten students had loads of fun on their FIRST EVER field trip to Deep Well Farm today! They each got a pumpkin to bring home and had a great time!

CAREER AND TECHNICAL EDUCATION

Aristotle — "Where your talents and the needs of the world cross, there lies your vocation."

The word vocation embodies more than just what you do for a living, but encompasses the application of the talents and gifts you possess. This application brings value to those around you and self-satisfaction in fulfilling a role for which you are innately prepared. In short, the true result of a vocation is not earnings, but contentment.

The partnership between Anderson County Schools (ACS) and the Anderson County Higher Education Center (ACHEC) works cooperatively to hone the talents of our students to fulfill the needs found within Anderson County. While there are many reasons for education, one of its primary roles is in preparing the next generation for work. Some work requires generalized training and some require specialized training. Whether this training takes place over a matter of months or years, the end result is a person well equipped to serve in their chosen profession.

The effort to accomplish this begins in primary schools. In an attempt to build a sure foundation, ACS and AHEC work jointly to provide exploratory opportunities beginning in as early as sixth grade. Last year, the two joined forces in developing summer "Tommy & Tammy TCAT Camps". These camps were offered to the general public, but an extra effort was made to include students that were taking advantage of summer education. Two field trips were taken in which every middle school within ACS explored both the AHEC campus as well as TCAT Knoxville. This event helped to shore up the need for a strong academic foundation by demonstrating its impact on postsecondary education and on career requirements. Both students and attending staff were able to add to their repertoire of answers when the question was asked "why do I need to learn this"? The work between ACS and AHEC merely begins at this point.

At the secondary level, the bond grows even stronger. This year the state of Tennessee state school board approved that as early as 9th grade students could use dual enrollment grant funds to pay for classes that specifically continue at TCAT schools across the state. In comparison, fall of 2023 dual enrollment class rosters are up nearly 95% over last year. Students are taking advantage of this earlier start in classes such as Cosmetology, Industrial Maintenance, Machine Tool, and Welding. Additionally, this connection is proctoring the continuation of learning and talent development after graduation. Currently at AHEC, ACS graduates are taking advantage of nearly all program offerings, with more students showing interest and enrolling for summer and fall 2023 class starts every day.

Our current achievements, while satisfying, do not prevent us from looking to the future. More dual enrollment opportunities are on the horizon. The immediate work is with ACCTC's automotive department and developing a meaningful connection with both the light vehicle and heavy vehicle (diesel) programs at AHEC. This dual enrollment opportunity will help provide a clearly defined path for students wanting to enter the Transportation sector. Additionally, a partnership is being discussed between ACCTC and the HVAC program at AHEC. This connection could allow students enrolled in the Architecture and Construction program of study to get a head start in the refrigeration technology field. One central theme for these discussions is that of industry recognized certification.

Industry certification has value both educationally as well as vocationally. As this school year began, Dr. Tim Parrott challenged ACCTC to pursue opportunities for each program of study to offer students a path towards ready graduate status. While there are several options to gain this status, the partnership between ACS and AHEC is poised to greatly impact this. The chief way is in the further development of dual enrollment connections and implementing certifications that are recognized three fold. First, the certifications are recognized among industry partners. Secondly,

Tennessee accepts those industry certs for ready graduate status. Lastly, certifications that ACHEC acknowledges for which students would receive post-secondary credit.

In preparing to bring Dr. Parrott's challenge to fruition, three separate teachers, representing diverse programs of study, attended a three day train-the-trainer program. This training allows instructors to be able to certify students in the use of precision measurement instruments. This industry certification was assembled in conjunction with Snap-On Tools, Starrett Tools and the Nation Coalition of Certification Centers (NC3). This certification is recognized at many post-secondary institutions and industries nationwide.

Even with ever changing dynamics in education, the economy and the workforce, the basic alliance between ACS and AHEC stands ready to work on the challenges ahead. Exposing students across the grade levels to a wide range of opportunities, developing dual enrollment classes and challenging students to compete within industry with career specific certifications all work together to set Anderson County apart. A world in which the citizens and youth of Anderson County can find contentment as they hone and implement the skills the world around them need.

I wish to add the following items to the Agenda:

- Requesting motion to approve commitment of a delinquent tax property being held by Anderson County (303 Hill Street, Rocky Top) for use in the Tennessee Emergency Broadband Fund-American Rescue Plan (TEBF-ARP) Broadband Infrastructure Grant by Highland Communications and Anderson County. Pending legal opinion/determination, commitment will either occur as a transfer, or long-term lease. (Grant award was \$15,481,719.33 for a broadband project to address broadband adoption, and digital literacy efforts in parts of Campbell, Anderson, Claiborne and Union Counties.)
- 2. Requesting motion to authorize the county mayor to enter into negotiations with Highland Communications regarding reduction in Anderson County ARP matching funds in lieu of property commitment for above Broadband package.
- 3. Appointment of Anthony Allen to the Regional Solid Waste Board term ending 9/2026.
- Requesting motion to authorize the county mayor to submit application for Energy Communities Alliance (ECA) Government Education and Outreach Grant on behalf of Anderson County, for benefit of outreach for Anderson County, and Oak Ridge Reservation Communities Alliance (ORRCA) and its membership. (Submission deadline Nov. 30, 2022—see attached guidance)
- 5. Update Only: Anderson County was awarded a Federal Lands Access Program (FLAP) Grant from the U.S. Department of Transportation Federal Highway Administration in the amount of \$1,851,400 for Gibbs Ferry Park. The Gibbs Ferry Park Project will serve as the Trail Head for both Green Way and Blue Way improvements which will provide both recreational and multi-modal transportation opportunities, as well as future greenway from Elza Gate Park. Scope involves asphalt pavement milling, asphalt

pavement overlay, shoulder reconditioning, drainage improvement, etc. Plans are to add lighting, restrooms, boat docks, additional parking, improved boat parking, enhanced picnic areas including ADA compliant pads, improvements for adaptive ADA compliant kayak/canoe launch, etc. to this 4+ acre park. The park has approximately 1,8000 linear feet of water and road frontage of approximately 1,300 feet. With traffic engineering, the project proposes possible turn-lane modifications, and relocation of entrance to alleviate traffic danger around park ingress, egress to/from State Route 61/Oak Ridge Highway.

ECA Local Government Education and Outreach Funding Opportunity for Frontline Communities

The Energy Communities Alliance, Inc. (ECA) is soliciting grants of up to \$50,000 for local governments, local government entities, councils of government, or Department of Energy (DOE) recognized community reuse organizations at sites impacted by DOE cleanup activities to increase education and outreach campaigns, and local government participation in DOE's environmental cleanup mission.

Grants will support the following activities:

- Increase education of local communities at EM sites regarding EM cleanup decisions, processes, and activities.
- Provide support to stakeholder groups to analyze plans/proposals and comment on models used, data relied upon, and choices between engineered alternatives or alternatives in National Environmental Policy Act processes.
- Increase public awareness of impacts of contaminant releases or potential releases and choices/priorities for cleanup and safety, with the specific objective of increasing public participation in decision-making.
- Provide resources for technical assistance for independent review of DOE and other environmental data from sites.
- Assist in building local government capacity to respond to DOE issues.

The deadline for grant application submission is November 30, 2022.

Grants will be awarded based on determination by a selection committee composed of five to seven individuals which may include ECA members. ECA staff will have final approval for each member of the selection committee. None of the selection committee members' communities will be eligible for grant receipt. The selection committee will have no more than 45 days after the grant application submission deadline to select grant receipts.

The grant period of performance is twelve (12) months.

ELIGIBILITY

The ECA Government Education and Outreach grants (up to \$50,000) are available to local governments, local government entities, (state created) councils of local governments, or DOE-recognized community reuse organizations ("Eligible Grant Recipients") at sites impacted by DOE cleanup activities.

Eligible grant uses include: supporting cleanup education, supporting the development of staff to work on EM cleanup issues, meetings, consultants, technical assistance, and other similar activities that focus on cleanup efforts at the Eligible Grant Recipients' respective sites. Grants may <u>not</u> be used for legislative advocacy efforts.

All eligible grant recipients are considered sub-awardees of the ECA federal grant (see Appendix A), and thus required to follow the same financial assistance standards as ECA. Recipients are required to follow 2 CFR 200: Uniform Administrative Requirements, Cost Principles and Audit Requirements for Federal Awards. ECA is responsible to ensure all sub-awardees meet these standards.

Within thirty (30) days after the end of the grant period of performance, grant recipients must submit to ECA an "Actions and Accomplishments" report, as well as accounting of how grant funding was allocated.

2) Issue forth a Writ of Mandamus for The Supreme Court of the State of Tennessee, Eastern District, Case No. E2022-1551-SC-WRM-CV to Order Judge Ryan Spitzer² to do his job and immediately issue forth orders as in Demands beginning page 25 of Petitioners' Complaint of Writ of Quo Warranto, Case No C2LA0108, filed September 20, 2021, in Anderson County Circuit Court, Anderson, Tennessee, as the Court has failed to hold a hearing in this matter despite multiple demands for a hearing in that Court. A Summons and copy of the Complaint of Writ of Quo Warranto were issued upon all Respondents and proof of receipt of service of such was filed with the Court September 27, 2022. None of the Respondents resigned, and despite many subsequent motions for a hearing of this matter before the Court, Judge Ryan Spitzer failed to hold a hearing for Respondents to dispute the evidence presented. Default judgment was motioned for in Anderson County Circuit Court, Anderson,

Tennessee on 11/01/2022, but Judge Spitzer has refused to rule on that motion, as well as all other prior motions filed in this matter.

3) Issue forth Writ of Mandamus to the judges hearing the brief in the case of Demandant Clark's Appeal, No. 22-5237 at the United States Court of Appeals, District of Columbia Circuit to A) issue forth an order (as none has yet been issued in this vitally urgent national matter) to Judge Carl J Nichols, (as well as judges Amy Berman Jackson, and Christopher R Cooper who denied Clark's daughter's original Writ and corrected Writ) to overturn their respective Orders of Denial which failed to protect the rights of injured voters in this matter at the United States District Court, District of Columbia, and 2)for Judge Carl J Nichols to joinder Clark's case with his daughter's prior cases in the same Court, and issue forth Orders and actions as demanded in the Writ filed

by Demandant Clark, including, URGENTLY, the immediate Order of all elected Respondents in that matter to immediately provide Election Assistance Commission certification certificates for every machine they were elected with in 2020, to prove that they were elected with machines certified according to federal HAVA law, or resign and we will hold new elections. These Judges have now delayed this vital national issue almost 2 years.

Chief Justice John Roberts will need to recuse himself from this matter, as he is named as a Respondent in Mr. Clark's writ as well as named in Mr. Clark's daughter's two prior denied writs.

In his order of denial, Judge Nichols joindered Mr. Clark's case with his daughter's two prior denied Writs, explaining as they were "nearly identical," Mr. Clark's Writ must be dismissed for the same reason(s) as his daughter's original Writ and later corrected Writ. Demandant Ayers and her father, Demandant Clark, hold that none of their Writs should have been denied for

"lack of standing and failure to state an injury" as both individuals have/had standing under common law not only as citizens and taxpayers, but also as an injured voter, with precedent for standing for an injured voter just set by two State Supreme Courts as related below.

ISSUES PRESENTED:

Petitioners presented multiple sworn affidavits in their original Complaint(s) of Writ of Quo Warranto from many computer programmers who swore that most all United States voting machines are able to be infiltrated at will and votes flipped at will. Sworn affidavit #1, was from Tore Maras, who was formerly sub-contracted by CIA Director John Brennan, and who flipped 47 foreign elections while under his direction, using this method of "rigged," vote-flipping with voting machines, but she protested when this scheme was implemented here in the United States, and her affidavit explicitly explains how the voting machines are accessed, and maps out the entire network of foreign intrusion into our voting machines and outlines a safe paper-ballot method for voting. Additionally, Petitioners presented a sworn admission from the foreign country of Italy admitting they flipped our 2020 election for President, naming names of who did it. Evidence was presented that our voting machines had been hacked by foreign entities in the 2020 elections and that they had flipped the vote tally for our Presidential election, that, the U.S.A. has seated a man as our U.S. President who did not get the most votes, and judges have either not held a hearing and made no ruling, or have

denied a Writ "because it was nearly identical to a prior[errant] Writ," thus taking away our right to vote for the candidate of our choice.

Issue 1: Failure of Judge(s)to issue Demand for Temporary/Permanent Restraining Order against the use of all compromised electronic voting machines and to order the use of paper ballots for elections using method described, and Order a full forensic audit of 2020 election machines and records, despite evidence presented that our voting machines are able to be infiltrated.

Issue 2: Failure of Judges to restore to Demandants their right to have their vote counted as cast

Issue 3: Failure of Judges to protect the United States of America by neither enforcing resignation, nor holding a hearing so the highest of our elected government officials could be made to present certification that they were legally elected with machines

certified according to United States federal HAVA law

FACTS NECESSARY TO UNDERSTAND THE ISSUE

Demandants Ayers and Clark have filed their original cases in the Anderson County Circuit Court, Anderson County, Tennessee,

and the United States District Court, District of Columbia, respectively, with their respective Appeals and Writ of Mandamus filed in the U.S. Supreme Court for the State of Tennessee, Eastern District and the U.S. Court of Appeals, District of Columbia, with no Order issued yet in either of their respective Writ of Mandamus/Appeal cases. Both their cases share the common issue that sworn evidence was presented that our United States electronic voting machines have been infiltrated, votes flipped, were uncertified according to United States Federal HAVA Law for the 2020 elections, and likely remain uncertified and vulnerable to infiltration and still have the ability to allow for infiltration and the flipping of votes for the elections on Tuesday, November 8, 2022, again stealing the right of each citizen in every

State and Territory of the United States to have their vote counted as cast, and Judges in both cases have refused to address this issue and protect Demandants' respective rights to vote and have their vote counted as cast. Because of above evidence presented that votes were flipped in the 2020 federal election for President and Vice President, Demandant Ayers and fellow

Demandants in their Writ in the Anderson County Case have Demanded a Temporary/Permanent Restraining Order against the use of all electronic voting machines and have demanded a full forensic audit of the 2020 elections, and Demandant Clark has Demanded in his Writ (among other things) that all 2020 elected Respondents resign or come to a hearing and (among other things) provide valid 2020 Election Assistance Commission-issued Certification certificates for the machines with which they were elected to prove they were elected with machines certified according to federal HAVA law in all States that took HAVA funding. Both cases have presented evidence to the Court that our United States electronic voting machines were compromised, and votes flipped, and likely remain in that same condition; uncertified, able to be easily infiltrated and votes flipped by anyone--including foreign enemies. As Ayers, et al are not only Tennessee residents, but U.S. Citizens and as this issue affects not only Tennessee's voting machines, but all of the United States' voting machines, and all U.S. citizens are affected by the flipping of federal elections in any State, we extend our demand for a

Temporary Restraining Order against the use of all voting machines to all States and Territories in the United States, not only Tennessee's machines. Demandants Ayers, et al and Clark presented the following evidence proving that our U.S. electronic voting machines *were* infiltrated and votes flipped for the 2020 elections, yet the Order and lack of Order from their respective cases show that Judges in both cases have refused to protect these injured voters and rule according to the law: Demandants presented this General Affidavit from a foreign country admitting our 2020 presidential election was flipped:

RESOLUTION NO. 22-11-970

RESOLUTION AUTHORIZING THE DONATION OF A SURPLUS ANDERSON COUNTY SHERIFF'S VEHICLE TO THE CITY OF NORRIS.

WHEREAS, Anderson County is in possession of 2011 Ford Crown Victoria, VIN: 2FABP7BV5BX108484 that has been declared surplus and no longer needed by the Sheriff's Office, and the City of Norris has indicated they are willing to accept this vehicle with a full release of liability as legal consideration for the donation; and

WHEREAS, Tenn. Code Ann. § 12-2-420 provides legal authority for the donation of county property to municipalities. That statute reads in its entirety as follows:

12-2-420. Transfers of surplus personal property among governmental entities.

(a) Notwithstanding any other provisions of law, counties, municipalities and metropolitan governments may purchase, trade or receive as a gift, upon approval of the governing bodies involved in the transaction, any used or surplus personal property from another county, municipality, metropolitan government, state government, federal government or any instrumentality of the foregoing, without regard to any laws regarding public advertisement and competitive bidding. A transfer of surplus personal property from the state of Tennessee must satisfy the requirements of § 12-2-407. Also notwithstanding any other provision of law, any county, municipality, or metropolitan government may by resolution or ordinance of its governing body establish a procedure for the disposition of its surplus personal property to other governmental entities, including, but not limited to, counties, municipalities, metropolitan governments, the state of Tennessee, the federal government, other states or their political subdivisions and the instrumentalities of any of the foregoing, by sale, gift, trade, or barter upon such terms as the governing body may authorize, without regard to any other provisions of law regarding the sale or disposition of used or surplus personal property.

(b) This section shall be construed as supplemental authority for counties, municipalities and metropolitan governments

NOW THEREFORE, BE IT RESOLVED, by the Anderson County Board of Commissioners meeting in regular session this 21st day of November 2022 that we hereby donate and exchange a 2011 Ford Crown Victoria, VIN: 2FABP7BV5BX108484 to the City of Norris subject to acceptance and provided that the City of Norris agrees to a full release of liability as follows:

The City of Norris agrees to defend, release, indemnify and hold harmless Anderson County from and against any and all claims or damage to property, or injury, or death of person or persons resulting from or arising out of the use, exchange, donation, operation or possession of the described vehicle by the City of Norris, including authorized and unauthorized uses. The City of Norris agrees to provide adequate insurance coverage on vehicle sufficient to cover any and all claims arising from property damage, injuries, illness, death related to use of vehicles; including, but not limited to, claims, charges, payments or judgments attributed to compensatory, general, incidental, consequential and punitive damages, and all attorneys' fees associated therewith.
