A RESOLUTION AMENDING THE "ZONING RESOLUTION OF ANDERSON COUNTY, TENNESSEE" BY PERMITTING PLANNED DEVELOPMENTS IN THE A-1, AGRICULTURAL-FORESTRY DISTRICT

WHEREAS, the Anderson County Board of Commissioners, in accordance with Section 13-7-105 of the <u>Tennessee Code Annotated</u>, may amend the zoning "Zoning Resolution of Anderson County, Tennessee"; and

WHEREAS, the Anderson County Regional Planning Commission and the Clinton Municipal/Regional Planning Commission have reviewed and made recommendations regarding the proposed amendment of the "Zoning Resolution of Anderson County, Tennessee", in accordance with Section 13-7-105(a) of the <u>Tennessee</u> <u>Code Annotated</u>; and

WHEREAS, public notice has been provided in a newspaper of general circulation for the public hearing to be held by the Anderson County Board of Commissioners to consider such zoning amendment of the "Zoning Resolution of Anderson County, Tennessee." with a complete summary of such amendment, in accordance with Section 13-7-105(b) of the <u>Tennessee Code Annotated</u>; and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Anderson County, Tennessee:

Section 1. Division 20, Agricultural-Forestry District Regulations, Section 020-010B, Special Exceptions is hereby amended as follows:

- B. <u>Special Exceptions</u>: In the A-1 Agricultural-Forestry District, the following uses and their accessory uses may be permitted subject to review and approval by the Board of Zoning Appeals in accordance with the provisions of Article 4, Division 75.
 - 10. Planned development, subject to the provisions of this code.

Section 2. This resolution shall become effective from and after its passage, the public welfare requiring it.
