



Call to Order – T. Frank called the meeting to order at 2:02 p.m.

Approval of Minutes

Motion made by P. Yager and second by S. Vowell to approve the minutes of the December 11, 2023, Board of Trustees meeting as presented. Motion carried by voice vote.
