Terry Frank called the meeting to order at 10:06 a.m.

Election of Chair: Commissioners Wandell made a motion for Mayor Frank to continue as committee Chairman. Second by Jeff Cole. **Motion carried**

Election of Vice-Chairman: Motion by Jeff Cole and second by Regina Copeland for Tim Shelton to continue as Vice-Chairman. **Motion carried**

Approval of Meeting Minutes from August 30, 2024

Review of Job Posting for Vacancy of Law Director's position
