RESOLUTION

A RESOLUTION AUTHORIZING THE CITY TO ENTER INTO AN AGREEMENT WITH ROANE COUNTY AND AN AGREEMENT WITH ANDERSON COUNTY FOR THE PROVISION OF AMBULANCE SERVICES WITHIN THE CITY LIMITS OF OAK RIDGE.

WHEREAS, at the first meeting of the City Council in March 1970, City Council adopted a resolution authorizing the Mayor to enter into an agreement with Anderson County for the provision of ambulance services within the City Limits of Oak Ridge, which included both the Anderson County portion of Oak Ridge and the Roane County portion of Oak Ridge; and

WHEREAS, in October 2023, Roane County completed construction of and staffed an ambulance station at the Gallaher Road exit off Interstate I-40, approximately 2.6 miles from the entrance of The Preserve on the west end of Oak Ridge; and

WHEREAS, currently, the closest Anderson County ambulance station to the entrance of The Preserve is located approximately 11.8 miles away at 184 Raleigh Road in a City-owned building; and

WHEREAS, Roane County has approached the City and requested to provide ambulance services to The Preserve as well as for a portion of the Roane County section of Oak Ridge, though not all; and

WHEREAS, Roane County has requested to provide ambulance services from the west end City Limits to the State Route 95 / Highway 58 split; and

WHEREAS, Tennessee Code Annotated §7-61-102 authorizes municipal governing bodies to make provisions for ambulance service within the boundaries of a municipality; and

WHEREAS, both Roane County and Anderson County are licensed by the Tennessee Department of Health Emergency Services as a Class A – Advance Life Support ambulance service and are in good standing with the State of Tennessee; and

WHEREAS, in order to support agreements for ambulance service with both Anderson and Roane Counties, the City's Dispatch Center's computer aided dispatch (CAD) will need to be updated to include the changes to the EMS provider, and both Roane and Anderson County E-911 will need to make the necessary updates; and

WHEREAS, planning for the needed upgrades to the City's Dispatch Center and Roane and Anderson County E-911 is underway, with implementation to begin upon approval by City Council; and

WHEREAS, the parties desire a projected start date of April 1, 2025; and

WHEREAS, the City Manager recommends the City enter into the necessary legal documents with Roane County and Anderson County for the provision of ambulance services within the City of Oak Ridge.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OAK RIDGE, TENNESSEE:

That the recommendation of the City Manager is approved and the City is hereby authorized to enter into the necessary agreements with Roane County and Anderson County for the provision of ambulance services within the City Limits of Oak Ridge, with Roane County providing ambulance service to the western portion of Oak Ridge from the west City Limits to the State Route 95 / Highway 58 split and Anderson County providing service to the remainder of Oak Ridge (which includes a portion of the Roane County section of Oak Ridge).

BE IT FURTHER RESOLVED that the City is authorized to make all E-911 and computer aided dispatch (CAD) updates necessary to support the changes to the Emergency Medical Service provider.

BE IT FURTHER RESOLVED that the Mayor and/or the City Manager are hereby authorized to execute the appropriate legal instruments to accomplish the same.

Memorandum of Understanding Establishing the Pellissippi Blueway

This Memorandum of Understanding (MOU) is entered into on [Date], by and among the following organizations:

(List in the following form)

[Name], with its principal office located at [address].

Collectively referred to as "the Parties."

Purpose

The purpose of this MOU is to formalize and document the cooperation and collaboration between the Parties in planning, developing, and maintaining a water trail on the Clinch River, to be known as the Pellissippi Blueway. The focus is on the Clinch River segment between Norris Dam and Melton Hill Dam.

Background

For a number of years, persons affiliated with several of the Parties and other citizens of the region have recognized the recreational potential of the Clinch River as a water trail and have sometimes informally called it a "blueway." In 2021, representatives of the Parties began meeting to discuss cooperative efforts to plan, develop, maintain, and promote the Clinch River as the Pellissippi Blueway. The National Park Service's Rivers, Trails, and Conservation Assistance (RTCA) Program has advised and assisted these efforts.

Vision and Values

The Parties share a common interest in the conservation and recreation of the wild lands and waters of the Clinch River and recognize the importance of establishing and maintaining a water trail on the Clinch River to facilitate recreational activities, promote environmental conservation, and enhance public access to the river. The Parties envision the Pellissippi Blueway as a regional recreation trail on the Clinch River that benefits visitors and local communities through partnerships that celebrate the area's rich natural and cultural resources.

Scope

The Parties agree to work together to plan, develop, maintain, and promote a water trail on the Clinch River. Activities may include, but are not limited to, trail design, river access improvements, design and installation of signage, maintenance, educational programs, and public safety.

Each Party is responsible for its own expenses related to this MOU. There is no requirement for, nor a prohibition of, exchanges of funds between the parties for tasks associated with this MOU.

Responsibilities

This MOU establishes that the Parties agree to work collaboratively. The collaboration is expected to develop and evolve over time.

Responsibilities to be enumerated (for all parties or for specified parties) may include, but are not limited to:

- Working together to promote public access to the water trail and develop educational programs
 that highlight the importance of conservation and safe and responsible recreation along the
 Clinch River.
- Establishing or maintaining specified public access points.
- Seeking funding through grant applications, partnerships with private donors, and other fundraising efforts. All parties are encouraged to contribute to the Blueway's financial sustainability, but are not obligated to do so.

The Primary Parties to this MOU are organizations with direct responsibility for managing land and water on or adjacent to the Blueway, including public access points. Collaborating Parties do not have a role in managing land and water, but intend to support the Blueway through education, promotion, fundraising, and related efforts.

Communication and Coordination

The Parties will establish a Blueway Steering Committee composed of representatives from each party to oversee project coordination, decision-making, and communication. Regular meetings will be held to ensure effective collaboration.

Branding and Logos

The Parties agree to accept the "Pellissippi Blueway" brand as defined in this MOU, agree to use the name and associated logos only consistent with this MOU, and use the brand and logos on their relevant signage and promotional materials as appropriate.

Designation of National Water Trail

All parties to this MOU are in support of asking the National Park Service to designate the Pellissippi Blueway as a National Water Trail.

Term and Termination

This MOU shall commence on the date of execution. Any Party may terminate its participation in this MOU by providing thirty (30) days' written notice to the other parties.

Liability

The parties entering into this MOU do not become liable or any way accept liability for the actions of other parties acting under the auspices of the MOU.

Amendments

Any amendments to this MOU must be made in writing and agreed upon by all Parties.

Governing Law

This MOU shall be governed by and construed in accordance with the laws of Tennessee.

Dear Mayor Frank,

We hope this correspondence finds you and your county doing well. Commissioner Lawrence and I appreciate the kind words about the Volunteer Firefighter Equipment and Training Grant Program. We are thankful for Governor Lee's leadership and the support of the legislature to fund this program over the last four years. We know how important these grants are to your departments in Anderson County and to the rest of our volunteer departments around the state.

We appreciate your offer of partnership with the state on a training facility in East Tennessee as we understand the need for firefighters to receive top notch training close to home. We did want to make sure you knew about the training opportunities already available free of charge to your volunteer firefighters. Several years ago, Governor Lee directed the State Fire Marshal's office to offer all firefighting classes at no cost to the men and women who serve our state as volunteers and all the classes they need, except for the live burn class, can be given at your local departments. The live burn class is also free of charge, including class training, room and board, but firefighters would have to come to the Tennessee Fire and Codes Academy in Bell Buckle to take advantage of the entire student experience.

We are grateful for your concern of the time and expense of the volunteers in Anderson County, and we hope the current practice of providing all the classes except for the live burn is serving your firefighters well. Currently, the state has no plans for regional academies but that could change in the future. There is a considerable commitment and expense in building and maintaining an academy which would require the support of our Governor and our legislative partners.

We appreciate you and the Anderson County Commission starting this dialogue.

SECTION 14. There shall be two full-time Judges for the General Sessions Court of Anderson County, Tennessee, one being the Judge of Division I and the other being the Judge of Division II, with the same qualifications and term of office as provided by the Constitution of the State of Tennessee for Judges of inferior courts; and such Judges shall take the same oath as prescribed for Circuit Judges and Chancellors. The Judges of the General Sessions Court of Anderson County, Tennessee shall be licensed attorneys of this State and residents of Anderson County, Tennessee. The Judges shall devote full time to the office and shall not otherwise practice law, and shall be paid a salary as provided in Section 15. The Judges of Division I and Division II shall have and exercise all the same jurisdiction and may hold court and hear cases in either Division. Both Judges shall devote such time as necessary between either Division to equalize the case load and to provide for the expeditious hearing of all cases in both Divisions. Cases arising in Division II of the General Sessions Court of Anderson County, Tennessee shall be heard in Oak Ridge, Tennessee subject to the City of Oak Ridge, Tennessee providing adequate courtroom and office facilities for the Judge and support staff.

The Judges of the General Sessions Court of Anderson County, Tennessee are hereby vested with all of the powers possessed by Circuit Judges and Chancellors to issue all writs of injunction, attachment, habeas corpus, ne exeat, and all other kinds of extraordinary process, returnable to the General Sessions Court of Anderson County, Tennessee, or to any other County Courts, Circuit Courts, Chancery Courts, or any other comparable courts of the State.

SECTION 15. The Judges of Anderson County shall be paid the same salary as provided by the general law in the State of Tennessee pertaining to the General Sessions Court Judges.

SECTION 16. That J. Leon Alkenes of Anderson County, Tennessee, is hereby named as Judge of the General Sessions Court of Anderson County, should this Act apply to Anderson County, and he shall serve until the first day of September, 1948, and until his successor has been elected and qualified. His successor shall be elected by the qualified voters of the County at the general election on the first Thursday of August, 1948, to serve until the first day of September, 1950, or until his successor is elected and qualified. His successor shall be elected every eight years thereafter for a term of eight years. Any vacancy shall be filled as provided by law.
