I wish to request the following items be added to the agenda:

- 1. Soccer fields adjacent to Anderson County Detention Facility: Requesting authorization to put a small gate, or cable at parking lot entrance of the soccer fields. The fields are under a lease agreement approved by the Anderson County Board of Commissioners, and the Lessee manages use for their own league, as well as others who desire to use the fields. There have been impromptu uses where folks have just shown up for organized activities. # A. <u>MANAGER'S REPORT</u>

- 1. <u>ACTION REPORT-</u>. There was a discussion regarding the YTD profit. Manager Clowers stated he believed the Authority should still finish in the black even though the YTD profit is \$100K less than last year. The Manager's goal is to have a YTD profit of at least \$100K at the beginning of March. That would cover the cost of the rate study and two managers' salaries and benefits for four months.
- 2. <u>BEECH GROVE PROJECT</u>- Manager Clowers requested a motion from the Board to approve Pay Request # 6 for \$ 253,070.50 to Nitzchke Communications—motion by Commissioner Irwin to approve, Second by Commissioner Irwin, 4 ayes, 1 absent, motion carried.
- 3. <u>1.0 MG TANK PROJECT</u>- Manager Clowers stated that a 12" ductile iron line to connect the tanks is being installed this week at a base cost of just under \$10K. The new tank will be in service by 1/28/25.
- 4. <u>HPUD TIE-IN-</u> Manager Clowers reported the Pre-Construction meeting was held today. Construction is expected to begin on 2/10/25.

- VI. Public comments- Mayor Frank discussed the request from the operations committee to address the water needs on Highway 116. Mr. Phillips and Jimmy Byrge are residents in the area needing water. Mr. Byrge discussed the need for public water to be brought to the area. Manager Clowers and the Board responded with much discussion and understanding of Mr. Byrge's request; however, the funding is not available to provide water service from Anderson County Water Authority.

# A. <u>MANAGER'S REPORT</u>

- 1. <u>ACTION REPORT-</u>. Manager Clowers reviewed the attached action report with the Board.
- 2. <u>BEECH GROVE PROJECT</u>-Manager Clowers reported to the Board that the project is 98% complete except for the dress-up and ditching. ACWA will release the retainage to the contractor once all the clean-up is complete.
- 3. <u>HPUD TIE-IN-</u> Manager Clowers reported this project is about 80% complete. We still have a road bore to complete. ACWA has the permit approved by TDOT, and Halls-Dale Powell has agreed to move their master meter to the other side of the road. This project is \$300,000 and the plan is to do one pay request and hold retainage until all dress-up is done.
- 4. <u>ACWA OFFICE HOURS-</u> Manager Clowers and Office Manager Teresa Ridenour discussed changing the current office hours and going back to our previous office hours to 8 am to 4 pm. It would save ACWA on office and distribution over time around \$20,000 a year. Manager Clower's recommendation is to change ACWA office hours. Commissioner Irwin made a motion to accept Manager Clowers recommendation to change the hours of operation to 8 am to 4 pm, Second by Commissioner Shelton, 5 ayes, motion carried.
- 5. <u>DISCUSSION OF POSSIBLE RENOVATIONS OF THE ANDERSONVILLE LINE-</u> Manager Clowers said he would get with Erin with CCI and get cost estimates to replace the 6" AC line and possibly use the remaining funds and get a project going to target the leaks on Hwy 61. Motion by Commissioner Bowles to authorize Manager Clowers to proceed with beginning field investigations, contact, and assessment of the project that would provide a replacement for the worst section of this line and possibly further, Second by Commissioner Irwin, 5 ayes, motion carried.
