Call to Order: Meeting was called to order by Maria Hooks, Chairperson.

Approval of Minutes: A motion was made by Michael Foster and seconded by Jason Brown to approve the October 2025 meeting minutes. Motion passed.

Financial Report: A motion was made by Katy Watt and seconded by Michael Foster to approve the FY 2026 Quarterly Financial Reports. Motion passed. Report attached.

Old Business/New Business

A motion was made by Katy Watt and seconded by Michael Foster to approve the FY 2027 Budget, Advertising Budget and proposed projects for submittal to the Anderson County Budget Committee. Motion passed.

A motion was made by Michael Foster and seconded by Charlie Smith to request that the Anderson County Attorney place a lien on the hotel property at the Clinton exit that has not remitted occupancy tax. Motion passed.

Executive Director's Report, given by Stephanie Wells

- The 2025 Visitation and Social Media Report was presented, which is attached. Wells highlighted the following items:
 - Visitation to the Adventure Anderson website dropped by 3.91% in 2025 versus 2024 visitation due largely in part to technical issue with the website hosting vendor. The issue has been resolved.
 - In 2025 the website had 258,005 users that performed an average of 4.43 events per user. An event includes a page view, click, scroll, etc.
 - Places (attractions and lodging) and Blogs are the most viewed content on the site and the top 10 most visited pages have changed to include the Ultimate Waterway landing page and the Venues Page as a result of the targeted marketing campaigns.
 - Paid Social outranked all other sources of acquisition four to one.
 - There was a 58.4% increase in reach of Adventure Anderson's Facebook content while there was a 56.7% increase in reach of Adventure Anderson's content on Instagram.
 - Adventure Anderson's social content performs higher than similar organizations when compared in the META platform.
- Wells distributed the 2026 content calendar for the first quarter which spells out the content that will be promoted in social media, blogs and newsletters. Calendar is attached.
- Wells reported that in the spring campaign will launch on January 15th.
