A. MANAGER'S REPORT

1. **ACTION REPORT** Manager Elrod discussed the attached action report with the board.

ARP PROJECTS-

- a. **HPUD BOOSTER STATION UPDATE-** Manager Elrod informed the board we did receive the booster pump portion of the booster station for the Hallsdale - Powell connection. We are awaiting the housing unit. CCI provided a right of way survey showing the station was not originally planned to be set in a good spot due to a drainage ditch and right of way. Manager is requesting for up to \$25,000 to help toward the cost since this station was planned to be self-installed. Motion by Commissioner Bowles we accepted the recommendation from the manager as presented for up to \$25,000.00, for Second by Commissioner Shelton, 5 ayes, motion carried.
 - b. **AIRBASE SEWER PROJECT-** Manager Elrod said that they are still working on camera inspections for the area.
 - c. **INDUSTRIAL TANK-** Manager Elrod said the retaining wall and fence is up, and the area looks good. He informed the board that the seller accepted ACWA's offer of \$45,000 for the property. Manager Elrod requested approval for signing the attorney's letter as provided in the attachment showing both the owner and ACWA have reached a mutual agreement pending further requirements. Commissioner Bowles made a motion to send the letter provided by the Manager and pay \$45,000 for the property price, \$5,000 for a survey, and \$1,500 for closing, for a total of \$51,500, Second by Commissioner Shelton, 5 ayes, motion carried.
2. **HINDS CREEK TOWNHOMES SUBDIVISION-** Manager Elrod discussed with the board the attached MOU, after much discussion. Motion by Commissioner Irwin to adopt the attached MOU, Second by Commissioner Bowles, 5 ayes, motion carried.
3. **WATER TREATMENT PLANT UPDATE-** Manager Elrod discussed options on the Water Treatment Plant update.
4. **SEWER -** Manager Elrod discussed with the Board sewer issues.

5. **SANITARY SURVEY:** Manager Elrod informed the Board he will be receiving the results soon from the Sanitary Survey and will present the results at the next board meeting.

6. **RAW WATER INTAKE COST AND LAUREL ROAD BOOSTER STATION UPGRADE NEEDS-** Manager Elrod discussed the cost with the Board and the need to replace the pump. He informed them the cheapest quote for a drive is \$26,956 and awaiting two more. He requested to spend up to \$ 26,956 contingent on getting a lower price from S&S or Brann Whittmore and Associates. Motion by Commissioner Irwin to approve up the amount requested by the manager, Second by Commissioner Rose, 5 ayes, motion carried.

7. **ACEDA-** Commissioner Bowles said he was asked to fill a seat on ACEDA as one of the representatives. He discussed the responsibilities and cost. He discussed how the water authority would benefit from being part of ACEDA. He estimates the cost to be around \$5,000 a year. He suggests having the manager be ACWA's representative. No action was taken at this time and will be discussed later.

A. MANAGER'S REPORT

1. **ACTION REPORT** Manager Elrod discussed the attached action report with the board.

ARP PROJECTS

- a. **HPUD BOOSTER STATION UPDATE-** Manager Elrod informed the board the pump station module is delivered, the housing unit is on hold until we work on part of the details where the station is going to be located onsite. CCI has provided the site survey. There are concerns with location on the survey and how the station can be installed onsite. He is going to talk to TDOT to see if they will grant us permission to put it on the flat right-of-way spot as described to the Board, he also wants to put up a fence to prevent illegal dumping.
- b. **AIRBASE SEWER PROJECT-** Manager Elrod said CCI has the contract and we are moving forward to the camera setup.
- c. **INDUSTRIAL TANK-** Manager Elrod said he has reached out to Robert Campbell for the survey, if priced accordingly, we are awaiting the survey to give Mr. Leach the plot map to sign off for approval and proceed to give to our attorney for closing on the property.

2. **WATER TREATMENT PLANT UPDATE-** Manager Elrod has reached out to the State asking questions on any motions to give permission regarding the land. He states he is waiting for a response.

3. **SEWER COLLECTION SYSTEM-** Manager Elrod stated starting July 1st ACWA will be working on the I & I and will be putting money into the budget for approval. This will provide a demonstrable plan of action to present to TDEC.

4. **APPROVE PENNY POLICY-** Manager Elrod presented a proposed Penny Policy, to round up to the next highest coin due to the penny shortage from our financial institutions. Motion by Commissioner Irwin to round to the next highest coin, make the change and reflect on the written policy, Second by Commissioner Rose, 4 ayes, 1 absent, motion carried.

5. **SANITARY SURVEY(JEREMIAH)-** Assistant Manager Jeremiah Sweat reviewed the Sanitary Survey results with the Board. He informed them our survey score was 98 this year. He had addressed his hopes for scoring 100 in the future. He also informed them the Lead and Copper sampling is set to begin June through September. TDEC is reaching out to help with rules and procedures.

Anderson County ADA Oversight Committee
Minutes for March 2, 2026

Present were Roger Lloyd, Commissioner Anthony Allen, Marian Wildgruber and Louise McKown.

1: Step Climber Device is for someone using a wheelchair or walker or cannot get down the steps when the elevators are out and in an emergency. Roger said that he cannot find a step climber with batteries that will last, unlike the one he bought. He knows that manual step climbers exist. It just needs two people beside both sides for a person to use it. Manual step climbers cost less than battery operated devices. They cost between \$800 to \$1,500. The step climber that are battery run cost between \$1,000 and \$5,000.

2: Roger has tried really hard to find a reasonably cost signs for any our buildings that have Braille and raised print with a slot for a paper for people to know where they are.

Louise suggested that we buy them just for the restrooms in the courthouse and possibly for the Senior Center's restrooms. They do exist in the courthouse, but they are too high and are on the doors, but they are not ADA compliant. Roger believes if we just take off the existing signs, it will ruin the finish on the door.

FYI: To be ADA compliant, all signs must be on the latch side of the door and to be 48 inches from the floor to the bottom of the tactile character and no more than 60 inches long, and to have Braille and raised along with the door number or in restrooms, a figure of a man or a woman.

Also, Louise asked Roger to switch the handle to the other side to flush the toilet in some of the courthouse's restrooms. The flush handle should NOT be on the side of a wall. If someone in a wheelchair forgot to flush the toilet, it would be impossible to reach over the toilet to flush it.

3: Anderson County Senior Center: The entrance to Senior Center has new two doors with doorhandles so that a person can open the doors with a closed fist or push button door openers. At the entrance, they now have a concrete pad rather than one that was there which was slippery and not level.

Louise noted that previously when she went in the Senior Center, the inside doors all had door knobs instead of level door handles and the signs for rooms were too high and did not have Braille or raised print. Louise is not sure if the Senior Center's restrooms have the sign is on the door or beside it. Hopefully, in one of the stalls has grab bars on the side of the toilet and on the back of it. And soap and paper towel dispensers are in reach of wheelchair users. (Even though these dispensers are ADA compliant, often wheelchair users cannot reach them because they have been mounted on the wall where the mirrors are and not near the sinks.)

4: Marian asked if we could have new members for this committee. She knows someone who has low vision who lives in Andersonville who would like to join the ADA Oversight Committee. Marian said she had to fill out a form to be on this committee. But when former Commissioner Jerry Creasey asked me and others to join the committee, we did not have to fill out a form.

Roger did not think it was necessary, but we need to know this. We also need to find out if this woman can find transportation to come to our meetings.

5: Roger said there is work going on at the Health Department's entrance. This was shown in our ADA survey decades ago. Members of the committee wonder where the entrances will be. Also, Louise noted that the existing accessible parking signs there are too low.

6: Marian also asked about polling sites and if we had assessed their entrances and parking lots. Yes, is the answer, but our priorities we are first will spend our funds for our county-owned buildings, then go to polling places, and then libraries. Commissioner Allen said the Anderson County Fair Association Building. The Election Department has changed one of the early voting sites from the Clinton Community Center. Louise said in the past the accessible parking spaces are not available there and it has a gravel parking lot. For overflow parking, accessible parking could be at Roane State College. However, to get to that building, voters have to go up a steep hill.

7: This in the third year when TDOT wants to know what we have done over these last three years and the cost of each item. We are not sure how much our allocations are for these past three years and if we have outspanned them Roger will ask Andrew Stone who is working with Roger and Mayor Frank to see if we spent enough, where it was spent, and if we spent over spent our ADA funds. Andrew is the Director of Human Resources & Risk Management Department.

8: The next ADA Oversight Committee meeting will be May 4, 2026

Discussion was held regarding the status of the road erosion repair at Anderson County Park. Chairman Palmer reported that she had met with Road Superintendent Gary Long, who has been working with engineering companies to determine the cost and path forward in repairing the roadway failure of Park Road.

Dear Chairman Palmer and Honorable Members of the Conservation Board,

Below are a couple of updates:

Claxton Park on property next to new Claxton School: Dr. Parrott indicates they are still working on architect and engineering plans for the space. To my knowledge, they are planning a bathroom and pavilion with the remaining park amenities to be determined by the Conservation Board. While you await the school's dimensions, details, etc., the Board may want to consider doing a RFQ (Request for Qualifications) for design firms to assist the board in designing the space. From there, you could get a proposal from respondents that you like. Typically, you would work with a firm, and they would organize some options for the space based on the survey results. You could then next step by having them present some ideas to the community for them to informally vote on. I'm happy to help if you like.

Grant updates: The Tourism Enhancement Grant for the signage at Lost Bottom Park is in process. The Firm Lose Design has been engaged and they will present some signage ideas as well as any construction documents needed to get proposals or bids.

The Lost Bottom Park NRDA contract has been received from the state. That contract is currently scheduled for final approval at the Commission meeting on the 17th.

Work continues on the environmental processes for Gibbs Ferry Park. Construction costs have escalated and we have requested additional funding from the federal funding program. We have received favorable responses but have no final confirmation yet.

Lastly, I have received several applications for the vacancy on the board and hope to have a confirmation soon.

Claxton Community Park Survey Results

Responses received from November 25, 2025 to January 31, 2026

Total Responses to Survey: 476

Claxton Community Population Size: 10,290

Confidence Level: 95% (Standard)

Margin of Error: ~4.37% (rounded to $\pm 4.4\%$)

Understanding Results Precision: A $\pm 4.4\%$ margin of error indicates a high level of precision, as it is lower than the common 5% research standard.

Interpretation: If 50% of your 476 respondents say "Yes" to a question, you can be 95% confident that the true percentage of the 10,290 people who would say "Yes" is between 45.6% and 54.4% ($50\% \pm 4.4\%$).

Impact of Sample Size: With a larger population, a sample size of 476 provides a solid, representative margin of error.

Question Number 5 Concerning Additional Suggestions

The question stated, “Do you have any other ideas or suggestions for the new design?”

The responses are listed below. Please note that the responses below have not been edited or altered. However, comments that were irrelevant to the survey or future Claxton Community Park were omitted from this report.

A building or shelter to use still in the winter for gathering events. Indoor golf simulator building, Public pool, Bowling alley, Skate rink. There are alot of ideas that this community could benefit from. Hope this helps.
A community pool would be nice.
A fence around the play area with gates that the older children and adults can open but the littles can't
A larger toddler area for smaller kids. All the parks in Clinton now don't have much of a toddler area to play.

A nature based playground and/or a wheelchair accessible playground. There are many options of play structures that include both stairs and ramps where kids with mobility equipment (walkers, wheelchairs, etc) can get all the way to the top with their peers.
A small area with a puppy park where kids and parents and pups can play
A stage area for community events could make this park a real community gathering place.
A thoughtful design that reflects nature would be wonderful!
A water area for the kids for use in the summer months so we don't have to go to Clinton or Powell
Adequate parking.
All inclusive a must.
Any park for the children of claxton is better than no park at all. I know my grandkids & nieces/nephews of the claxton community would love it no matter what. We love the area that the park is at.
Avoid a cheap plastic standard playground. Most kids get bored quickly on them.
Baseball park would be such an asset to the community
Beautiful landscape, shade
Bring back the kids bash. Community park celebration day. Miss the events and the community coming together just to let the kids run free and have fun.
Build the playground like the original one, make it look like a castle!
Climbing wall could be used by all ages
Community garden
Community pool
Convenient access to the park not impaired or in competition with the new school.
Do not do wood chips, rubber pieces are still a choking hazard but not as high risk as the wood chips. Have it fenced in. Open year round.
Don't just use the same basic plastic pieces that are available in other parks. Keep the unique structures of the original park. And unique play spaces like the sandbox and open fields and creek.
Fence it in
Find a way to keep out trouble and drugs
For all ages not just little children. Aspire it's harder for 7-12 year olds to play on if they are taller.
For the playground, please consider limiting "death drops" when choosing a layout for the equipment. Karns community park has 2 separate play equipment for over and under 5 and a fenced play space.
Get inspiration from Aspire Park playground
Get it done sooner than later.
Good lighting
Greenway - Safe place to walk and ride bikes
Has the consideration for utilizing the current Claxton Elementary School area once it moves to its new location?
Have you looked at the area between Clinton Hwy and Old State? It used to be a roadside park years ago and needs lots of work.
Hopefully the new park can be built on land donated by the board of education at the current elementary school. At least one of the smaller buildings could be used as a

I would like to see the current gym and the new building at the far rear of the school be used/incorporated into the new park. That playground could be seriously updated as well.</p>
<p>I feel like it should stay the same. Just add a few things to it. Splash pad. Basketball court. Bathrooms at least 2. No porter pottys (nasty). Pave the parking spaces and add lines. (Where gravel is). Also add more picnic tables around it sometimes other people like to picnic in the sun. Take the sand part out.</p>
<p>I grew up going to this park on an almost weekly basis and actually cried when I found out it was going to be torn down. New features are nice but the most important thing to me is that it still feels like Kid's Palace. The playground should still be the big, wooden jungle gym type. These kinds of playgrounds are far and few between now and the uniqueness is what makes Kid's Palace so special. There are regular/plastic playgrounds everywhere. Of course I don't expect it to be exactly the same but please keep the playground equipment wooden with lots of play structures.</p>
<p>I guess the new site will dictate the layout and amenities able to be included. So I'm unsure the size of a walking trail will be, but it would be nice to have several paths. Trash and recycling bins.</p>
<p>I know that safety regulations have changed since I've been a kid, but the new metal playgrounds always seem to get scorching hot during the summer. Also since they're so cookie cutter it feels like every park that has one is the same. If we could keep a child safe wooden structure, I think it could be used more in the summer. Also if there was a small seperated area for kids under 5 that'd be helpful, I've got a two year old and I'm always having to go in and run interference so she doesn't get steamrolled by the bigger kids running around. She also loves swings, and early on couldn't do too much, so hopefully the new park will have more than one or two basket swings so their smaller kids can be occupied while their older siblings get to run around.</p>
<p>I love the location. Shading with either trees or sun shade sails would be wonderful</p>
<p>I suggest you build this playground since the community was robbed of a place that was loved.</p>
<p>I think it is important for children's safety that the playground is fenced in especially when there are roads nearby.</p>
<p>I think the playground and the EMS station should be placed in the same area rather than looking for separate locations.</p>
<p>I would like to see a park that rivals the one in South Clinton. I understand that \$250,000 would have to stretch a long ways. I hope that there's going to be opportunity to buy a brick or two engraving as a donation much like the one in South Clinton. I do not agree with moving the parking in the first place, but if the park must move, this needs to be a good place for the entire community to go to. We have done birthday parties and church events at the old park in unison with the community center..</p>
<p>I would like to see Anderson Co. research and find companies who specialize in safe modern playground designs. I am favorable in the Fort type structure, instead of individual pieces that don't challenge the children's imagination. With today's building industry, there are many types of composite woods available (Trex, Timber Tech) that would allow for a</p>

similar type of structure as we had. These types of materials last for years upon years, with hardly no maintenance. I would try to negotiate with TVA and have the old existing location mitigated for clean up and try to locate the park in the same location or area. It is an idea site, a shelter still left, parking area could be improved, visible from Highway, a small restroom facility could be built and an excellent playground site for our community. The old school(currently existing school) site would also be a great opportunity for the new playground. But, please do your due diligence and research and spend this money wisely. Claxton deserves this action from you and the entire county & surrounding areas would prosper from this new playground.

I would love some pickle ball courts

I would love to see a path around the park that can be utilized for things like, a story walk; field identification of local plants.

I'm excited to see improvements to Our community in Claxton, we have been neglected far to long.

I'm not sure if the old Claxton community center will exist anymore or not. But I feel like the park needs large playground, lots of grass play area, restrooms, community center building, multiple covered picnic shelters. The park in South Clinton is a good example of a nice park.

Out in a facility that everyone in the community could take advantage of.
Pickleball courts please. All family members young to old can play and play together!
Place the park in a space that is not tied to other fixtures so there cannot be any confusion about maintenance year round or daytime usage. The public should not be allowed wandering around on the school grounds at any time.
Plan long term for greenway connection over bridge to haw ridge and greenway in oak ridge. Incorporate trail access if practicable to location or pedestrian and bike access to the park.
Plant shade trees and grass areas to sit on ground to enjoy picnic or just talking with family or friends
Playground to have shade structures, covered picnic area, many elements of the Claxton Park were so fun. The kids loved the wooden playground and all the different levels and things to climb and play on. Not many playground like that anymore.
Please add a tire swing, I'm begging you. If you don't I'll be so disappointed the old tire swing was my life and then it broke and yall took it out. I need a tire swing.
Please consider using nontoxic playground materials where possible. If the old structure had to be torn down due to public safety concerns, the new design should take children's health into consideration.
Please do not use recycled tire rubber chips. It is highly toxic and as someone who has lived in Claxton my entire life, I would not take my kids there if that were the case.
Please dont use rubber mulch, it is toxic and this park area already struggles with toxicity
Please keep the Palace design. It's unique and my kids love it!
Please lean toward more natural ground materials for our kiddos and avoid things like turf and recycled tires.
Please make it safe for children.
Please make sure there are cameras for security and everyone's safety and limit the number of gates in the fence surrounding the playground area. PLEASE fence in the playground area
Please make the playground toddler friendly with shade on the playground !
Please please please preserve the expanse of the existing park. This is my son's favorite park, and was his dad's favorite when he was a child, 30 years ago. Please don't skimp on the playground aspect. A wood playground with castle and climbing is so so so integral to children's growth. Shaded areas for parents to watch their children from would be lovely. A shelter is not inherently necessary but would be nice, with a permanent bathroom.
Plenty of swings (all kids love swings), grass area big enough for a lot of kids to run & play perhaps pass football, frisbee, etc. As a mother of 6, bathrooms are a must!
Put in a splash pad that has more than the couple tiny features the clinton and other splash pads have,
Put it somewhere pretty and secluded. Nobody wants to enjoy time at a park if it's located by a junk yard, etc.
Put the new playground on Anderson County property, not Anderson County Schools property. This gives some control of access to the park to the school system.
Question #4, I would also want to see artwork or a mural reflecting the history of Kids Palace.
Regarding the memorialization, my grandfather was one of the men that helped build the park. He worked at Y-12 and said other men from there helped as well. My grandfather passed two years ago, so he isn't alive to see what's happening with the park. But I am. It stings a little to know my kids will no longer be playing a piece of something my

grandfather helped build for the kids of the community, like my own. A plaque and mural would be beautiful! However, murals are the first thing vandalized as well, unfortunately, so naming a section would feel more permanent.
Replacement of community center for indoor events
Rules and regulations of park usage clearly states and posted. Safe environment and well lit. Inviting to ALL visitors and residents of the community. Some natural space included like gardens or open space areas. Thank you.
Safe Entrance into/out of the park, Adequate parking
Safe, Well lit, Available room for a vendor or two
Safety fences around the playground are a very important component to this area to help protect the kids in the play area.
Safety first
Shade over playground so equipment isn't hot to the touch and the community can use the space without overheating.
Shades sails like at Karns Community Park for kids to stay safe during summer play. The park at Morningside is a great example for a park design.
Simple just the equipment for kids to play on swings, slides, monkey rings. Nothing fancy just basic high quality play equipment made from materials that don't rot. And NOT at the school. Somewhere when anytime you can go.
Since parks are not an essential responsibility of government, I would suggest getting the county's fiscal house in order first. High debt load, millions in interest, terribly paid employees-all while having the eighth highest tax rate in Tennessee.
So many children enjoyed playing community baseball and football in this wonderful community. I'd like to see that continue, if possible.
Soft ground (rubber, turf, padded) in kids area
Zip line
Splash pad, pool if there is room.
Splash pad. It's great space for it, and the one in Clinton is tiny and Oak Ridge doesn't have one.
Swings are very stimulating and safe for very young children. Babies, especially ones who can only crawl, are obsessed with swings but can only sit in bucket seats. Please ensure that you have more than one or two bucket swings as this is typically their main attraction at parks. The swings where an adult can swing with a baby is a fantastic idea that we love using. Maybe think of another thing or two for toddlers. I notice most parks around here don't cater to ages 0-3, which is the age that most kids start going to parks. Parks need to feel and be safe for the kids and the mothers/families visiting. I believe a sheltered picnic area will welcome troubled people who don't necessarily belong at a park around children.
Most of our parks lack appropriate shade. During the summer park equipment get excruciating hot to the touch. During a recent trip to Charleston there was a park that had huge shade sails to keep the children and park cool.

The most important thing to consider when building this new area is a safe space for children to play. A picnic shelter area would be excellent for those who wish to host gatherings and birthday parties in the new location. If you go big on landscaping you'll have a big landscaping bill. Keep it simple and functional and safe!

The new area needs to be convenient for the community to use. It doesn't need to be next to the school due to the fact that it would be a safety issue to have people on/next to school property during school hours. As a parent I would not want "unauthorized" people walking /playing next to the school during school hours.

The new park should be an all around family fun place to go regardless of event. Having kids and parents activities available.

The old school would be a great place buy you would have a gym for ball, make a football/soccer field. Plenty of space and CB parking.

The park should be a place for families with younger children and grandchildren to go and safely play. Adult exercising equipment shouldn't be incorporated with this park as melton lake park already has this equipment.

The play palace should be preserved to the extent possible in the relocation to honor and preserve the work of the community members who built it.

This is the area for additional comments

This needs to be 100% community involvement. Don't make decisions unless you consider the voices of the people. Claxton is a forgotten town in our region. The children and citizens in the community need a safe and sophisticated area to gather, kids to play safely and be a new community staple. I also urge to do SWOT analysis of other parks nearby (Oak Ridge, Farragut, Powell) to see their strengths and weaknesses. Give Claxton a park we can all be proud of that's safe and resourceful to all. Don't take this away. I would urge to also have the backing of local legislature endorcements to have this pushed through. There should be plentiful money resources from multiple "buckets" if you will. Utilize our tax monies from tourism (however we could have that incorporated.) thank you!

This park needs to be for children. Anything todo with adults working out needs to be away from the children. The water pad in powell was great. Until they added the adult equiright ontop of it. Then the little girls no longer wanted to play while they felt adults were watching them as the worked out. So be smarter.

This survey is being conducted more than a year after the decision was made to demolish the community park. Unfortunately, community input was not meaningfully considered at the time, and the decision appeared to prioritize authority over the best interests of the children and families of Claxton.

The new park should not be located on the Claxton Elementary School campus. A community park should be in a separate location that is accessible to the public at all hours. While the school system and county leadership may state that access will be permitted, it raises valid concerns about safety, traffic, and supervision. Introducing additional visitors and potential issues onto an elementary school campus is not a prudent long-term solution.

If land availability is a concern, the county could consider using a portion of the existing elementary school property to develop a dedicated park space that is clearly separate from school operations. This would be a more appropriate and secure option.

The county government exceeded its appropriate role by making this decision without sufficient community engagement, turning what should have been a community-driven

<p>process into a political one. A significant majority of Claxton residents supported keeping the original park.</p> <p>I respectfully request that the county identify a separate location from the new school site and construct a community park that is equal to or better than the one that was removed.</p>
